DEAR TASKS UNLIMITED COMMUNITY,

Since I first came to Tasks as Executive Director in 2009, I've been proud of Tasks Unlimited's programs and our commitment to revising and designing services with client input so that we can best meet the needs and goals of all our participants. Last year to offer more accessible drop-in services for people experiencing homelessness, Tasks' Northeast Outreach & Opportunity Center (NOOC) moved to a new space at Mill City Church. We also launched new mental health counseling services and completed planning for a new resource center which opened this past January and is fast becoming an essential resource in the community. This welcoming space gives people new ways to access mental wellness support, connect with peers, find employment, housing, and other resources. Meanwhile, our Jobs Training Program has expanded to help participants pursue a wider range of employment pathways across the community. All these programs help us make sure we have a broad continuum of services and meet people where they are.

As Tasks opens these new doors to the community we serve, I too have something new ahead of me. I will be retiring from Tasks in December 2023. This transition has been in the works since last December and the Tasks Board has hired a search committee and is beginning an active national search. I'm confident the next leader will love Tasks the way I do and will continue to find those doors that need to be opened for the community we serve.

I want to thank you all for your trust and support both professionally and personally over these past 14 years. It takes a community to build a community and you all have been that; a community of great donors, clients, staff and board. I will miss the Tasks community but take with me very fond memories and the knowledge that we opened doors...together.

ANTHONY'S STORY

As reflected elsewhere in this annual report, Tasks Unlimited staff and participants are finding ways to link our different services, bringing all our resources together to help people gain the stability and opportunity to make new strides.

This has been the theme for Anthony, who recently sat down with us to share his experience with Tasks. Anthony came to Tasks only a few months ago. His path here, like many of our participants', began at a time of great instability and difficulty. During a period when he was homeless, he attempted suicide, leading to a brief stay in the hospital. From there he was discharged to an Intensive Residential Treatment Services (IRTS) facility. While helping out with cleanup around the building, an IRTS employee mentioned Tasks, telling him about the janitorial employment pathways available through our Jobs Training Program (JTP).

Anthony moved into the Tasks Transition Lodge shortly thereafter, where he quickly enrolled in, and graduated from, the Jobs Training Program. This led directly to a job with the Tasks Unlimited Building Services (TUBS) program, where he now works part-time, five days a week.

How has Tasks made a difference in his life? “Tasks is great,” shares Anthony. “They helped me move and helped me get resources I couldn't get on my own. Tasks just helped me out completely.” Compared to his time at the IRTS, Anthony values both the housing stability at Tasks' Transition Lodge, as well as the independence the Lodge allows residents. “I like the freedom we get,” says Anthony. “It's like having your own place, basically, and it's nice and it's affordable.”

Along with the work experience and steady pay, Tasks also offers Anthony access to mental health support whenever he needs it, both on the job and at the Lodge. “I can talk to [Lodge Coordinator] Tania anytime I want,” he says.

Meanwhile, he's also tapped into Tasks' new Resource Center, where Anthony and other Center visitors have access to a range of referrals, resources, and activities, from job search support to social outings like bike and boat rides.

Along the way, Tasks Resource Center Vocational Coordinator Danny has helped Anthony explore other job opportunities aligned with his interests and goals. A longtime animal lover, Anthony recently applied for a job in a pet store. Knowing that reliable, satisfying work is not the only key to long-term success, Danny and Tania have also helped Anthony plan his next housing chapter.

At the time of this writing, Anthony is exploring different job and housing options. While there have been setbacks, Anthony has made great gains in a few short months. With Tasks support he's identifying the next steps in his journey.

Tasks Unlimited mental health, housing, and employment services strive to provide opportunities for people with serious and persistent mental illness to live, work and recover in a safe, supportive community.

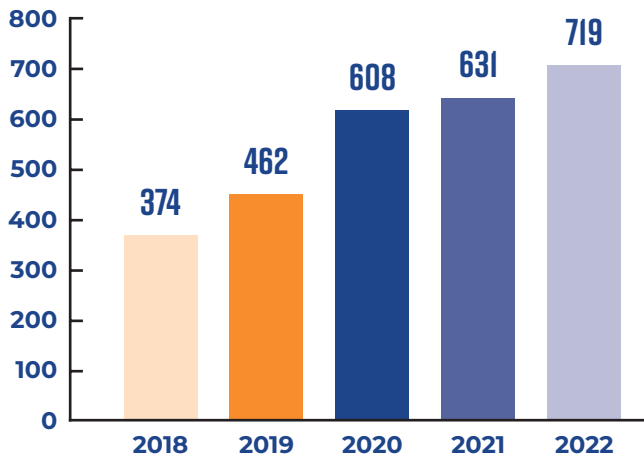

2022 OUTCOMES & HIGHLIGHTS

719 people received mental health, housing, employment, or outreach support.



Case Management services continued to grow—**294** people participated with **64%** meeting their goal.

New **Mental Health Counseling Services** launched to meet the need for more mental health resources and reduce barriers through telehealth and sliding scale fees.

MENTAL HEALTH SERVICES

- **510** people received mental health services.
- **96%** of clients successfully managed their symptoms, avoiding hospitalization.
- **84%** of clients receiving housing or employment support said Tasks helped them improve their mental health.

HOUSING SERVICES

- **163** people experiencing homelessness came to the NOOC drop-in center in NE Minneapolis for basic needs and support—a **38%** increase from 2021.
- **91** individuals resided in one of Tasks' 17 Fairweather Lodges.
- **81%** of Lodge residents reported greater housing stability since coming to Tasks.

EMPLOYMENT SERVICES

- **85%** of clients increased their income through our Jobs Training Program which was selected for a Hennepin County pilot to help people on public benefits navigate re-entry to employment.
- **217** individuals secured or maintained employment with support from our vocational services.
- **86%** of jobs training graduates were still working six months after graduation.
