LINDA'S STORY

A conversation with Linda Kubalsky, who has been engaged with Tasks for the last 19 years, is like talking through several chapters of Tasks' history.

Linda first came to Tasks in 2005 as a resident at our Oakwood Lodge. Since closed, this Tasks housing community for mothers and their kids in Minneapolis helped Linda find stability at a tough time in their life. Parenting two young children and facing mental health challenges, Oakwood "was a good thing at the time, something I needed," Linda says. "Looking back I got some really great support there from staff."

It was at Oakwood where Linda's journey from client to staff member began to take shape. "They saw potential in me shortly after I arrived," they recall. In their first year at Oakwood Lodge, Linda spoke at a Tables for Tasks fundraiser and at an event in Duluth.

At the time they took part in Rehab Squared—another Tasks program no longer active—visiting different Lodges to paint, hang sheetrock, tile bathrooms, and more. Linda worked with Rehab Squared for seven years, when a fellow Tasks employee asked if they had an interest in a peer support services role. They eased into this work by starting at Tasks' Senior Center, playing games and doing other activities with the residents there.

When the Senior Center closed, Linda transitioned to the Tasks Unlimited Training Center (TUTC) for Intensive Residential Treatment Services. The peer support work at the TUTC was different, says Linda.

"Being an Intensive Residential Treatment Service, we've got people coming in from hospitals or the prison system. They're probably in the worst part of their lives as far as mental health goes."

To best support TUTC participants, with Tasks' support Linda earned their official certification as a Peer Specialist.

"You're working with a lot of people that are either new to the mental health system or people that have been in it for a long time, and they just need the help," Linda shares. Adapting as they go, Linda has learned how and when to share their own story as a peer. "My story has helped some...You learn how to tell your story. You learn when to tell your story and when not." Over the course of eightplus years as a Peer Specialist, Linda says, "I've worked on my own skills, and my own mental health has improved drastically."

This March, Linda took more big steps in their journey, taking on a new role as IRTS Coordinator at the TUTC and transitioning to a full-time Tasks employee. "I ended my services with Tasks as a client on March 1," they say. "I'm now a Tasks employee, and I love it." With a full-time salary, Linda moved into their own apartment. "I love having my own place," they share.

Reflecting on their Tasks' experience of 19 years (and counting), Linda says, "What I really like about Tasks is, it's peer supported, plus giving you the skills to live out in the community and being able to work."

What's next for Linda? While they are considering going back to school for a social work degree, "I really love what I'm doing right now because... I know what [Tasks participants] are going through, I know the importance of finding housing and employment and everything in a timely matter, and [I know] what that does to you if that doesn't happen. ...And I feel like I can be an advocate for people who aren't in a good place right now, so they get the best services possible."



2023 OUTCOMES & HIGHLIGHTS

817 people received mental health, housing, employment, or outreach support.



The Resource Center opened in Feb 2023. As a new community support program, the Resource Center aims to decrease barriers to other long term service needs.

In its first year, the Resource Center served 113 people, many of whom visited the Resource Center multiple times. In addition to service navigation, the Resource Center provides a safe space to build community.

MENTAL HEALTH SERVICES

- 391 people received Case Management services, 161 of whom were new to Tasks.
- **89%** of participants report that their overall mental health recovery has improved since coming to Tasks.
- **98%** of those served in Lodge and Jobs programs were not hospitalized.

HOUSING SERVICES

- **9,886 hours** of housing services were provided for **90** people, helping those with significant barriers sustain their housing. **85%** of those participants were also engaged in additional programming at Tasks.
- **78%** of those served report having greater housing stability since coming to Tasks.
- **161** people were served at the NOOC. Of those, **78** received housing search services.

EMPLOYMENT SERVICES

- **84%** of persons served maintained their employment during the year.
- 131 participants completed financial literacy training and benefits cliff support services, learning more about how to avoid the Benefit Cliff impact when starting work.
- **75%** of persons served reported greater employment stability after coming to Tasks.
